Ukawia Johnson, LMSW District 1

Alabama while also ensuring the public's protection.






Dr. Shalunda Sherrod, LICSW District 5

Hello fellow Social Workers! I'm Wendy Russell Peek, LICSW, PIP. I attended UA, Tuscaloosa from Aug. 1986 - May 1990 where I graduated with a B.A. in Psychology. I returned to Tuscaloosa after working for the CDC in Atlanta as a Disease Intervention Specialist (that's fancy talk for syphilis contact tracer), for a residential psych facility for adolescents, and for Bradford Adolescent in Pelham. I took advantage of the Mental Health Concentration offered by the

MSW program, and after a field placement on the adolescent psych unit at Walter Reed Army Medical Center, I received my MSW in 1994.

I began my career as a licensed Social Worker over 28 years ago at a residential psychiatric facility for adolescents, and for sexually reactive youth. I moved to AL two years later to work in therapeutic foster care for two years before transitioning to an outpatient therapy role specializing in adolescents. In this role, I provided individual, group and family therapy, in addition to inpatient psych services on a rotating basis. I eventually made my way to private practice. While in private practice, I provided contract services for a day treatment program for HIV positive clients with substance use disorders. With rheumatoid arthritis and a baby on the way, and COBRA running out, I needed health insurance, so I went to Chilton County DHR as a foster care and protective

service caseworker. I left after seven years to head up the Social Work Department in the first

state-funded public defender's office in AL (Jefferson County). I later returned to CCDHR for three and a half years where I was a CA/N Investigator, provided clinical supervision to LGSWs, and taught a Social Work class at UAB before leaving for my current position as Psych Social Work Manager for UAB Center for Psychiatric Medicine (inpatient and emergency departments).



Dr. Robert McKinney, Jr., LICSW District 7

Hello! I completed my BA in Philosophy from Mississippi State University and my MSW and PHD from the University of Alabama School of Social Work. I've been a social worker since 2008. I've done community mental health, nonprofit leadership at a family resource center, at-risk youth in both aftercare and secure settings, and am currently on the faculty of the University

of Alabama College of Community Health Sciences, where I am the director of the Department of Social Services. At UA, I also teach two courses in the School of Social Work's DSW program. I consider it to be an honor to serve as a state regulator because I believe in the importance of licensure for social workers at all levels and the importance of maintaining the integrity of our profession. Serving on the board has provided me with insight into the seriousness with which the board, via its seven members, deliberate the various issues that come our way. This has perhaps never been more important, given the combined responsibilities associated with our licensing and oversight of social work supervisors and the Association of Social Work Boards' bold move to release licensure pass rate data.

## **Frequently Asked Questions**

Does the Board accept virtual training as classroom hours for required CEU's? **YES! As long it was live and interactive. It cannot be prerecorded.** 

Can transcripts be emailed to the Board? YES! We accept emails from the Universities or Colleges or their designated clearing house. Please email to <u>info.socialwork@swb.alabama.gov</u>

If I signed a supervision contract in 2020, am I grandfathered in or do I need to resubmit a new contract for supervision? YES! You are grandfathered in under the old rules. If a contract was approved before May 1, 2022, you are grandfathered in. Your supervisor is also grandfathered in and would not have to complete the training. Any contract signed after May 1, 2022, is subject to new rules. If you are a LMSW this means you now must receive 2 years of supervision – clinical or non-clinical. And supervisors will have one year from the date of the approved contract to take the supervision training and register with the Board.

What if my supervisor does not receive the training or register in a year? **Do not worry! The Board will allow you to use that year of training towards the required 2 years.** 

If I am a LMSW who has registered as a supervisor and then become a LICSW do I have to retake the supervisor training? **YES! You would need to take the clinical portion of the training.** 

How many hours of supervision are required? **96 total hours are required for all licensees. A minimum of four hours per month is** 

required. If fewer than four hours per month is reported at termination, we will not accept the month or time. Example: A supervision termination is submitted to the Board for a total of 30 Hours over a nine-month timeframe. That only comes out to 3.3 hours of supervision per month. We would not accept this.

# **BOARD UPDATES AND REMINDERS**

- At the August 24<sup>th</sup>, 2022, Board meeting the following regulation change was approved – licensed independent clinical social workers must have two years post licensure experience before becoming an approved board supervisor. The change was approved based on data from other state social work regulatory boards. It will align the board with numerous other states that require post licensure experience before becoming a supervisor. The Notice of Intended Action (NOIA) has been submitted to the Alabama Legislative Services Agency and a copy will be available on our website September 30, 2022. This new rule change will not apply to those who have already taken the supervisor training. If you have comments, please submit them before 4:00pm November 4, 2022, to the following email address rachel.dickinson@swb.alabama.gov
- New applications do not require Board approval. They are approved in office. Please keep in mind it can take 14-21 days to receive approval.

• Transcripts, immigration compliance forms, and license verifications from other states can

now be emailed to the office at <u>info.socialwork@swb.alabama.gov</u>

- If you submit a transcript to the office, please let us know if it is in different last name other than what is on your application.
- CE requirements you must have 3 CE's in the following Ethics, Clinical (if you are a LICSW) and Supervision (if you are under contract to supervise). Please remember that you need 10 classroom-based CE hours as part of your 30 CE total. Live/interactive webinars will count toward your classroom requirement. Recorded webinars are not considered live. Please keep in mind you cannot earn CEU's during your 60-day grace period.
- The Board will meet again October 20<sup>th</sup> in our Montgomery office.

### **BOARD OPENINGS FOR DISTRICT 2 and DISTRICT 5**

The Board currently has two Member positions open for appointment immediately. The positions are for **US Congressional District 2 and District 5** (please see the map below). The positions open are for Licensed Independent Clinical Social Workers who are current and in good standing. If you are a licensed social worker at this level of licensure from either District and are interested in serving on the Board, you may start collecting letters of nomination from fellow social workers from your District. The nomination letters and a resume must be mailed to the Board at 100 North Union Street, Suite 736, Montgomery, Alabama 36104, postmarked by September 30, 2022. The Governor makes the final selection from the list of the persons with the most nominations for the District.

If this is not something you're interested in, you may wish to submit a letter on behalf of someone. We'll accept nomination letters through September 30, 2022. We then submit the top three names for the District who receive the most letters to the Governor.

The Board appointment will be for **three years** running through September 30, 2025. There is no pay for serving under this capacity, but you are reimbursed for in state and out-of-state travel expenses at the same rate as a state employee.

#### The duties of the Board are:

- To protect the public from incompetent, unethical and unlawful social work practice.
- To enforce qualification standards for all levels of licensure and certification.

• To delineate unlawful conduct through disciplinary procedures against practitioners who violate

applicable laws or rules.

#### **Nomination Requirements:**

- The person being nominated and the person doing the nominating **must** both live in the same District.
- You can nominate yourself.
- The person making the nomination must be a licensed social worker.
- Nomination letters must be mailed, or hand delivered, you may collect the letters and send them in all together faxed or emailed letters **are not** acceptable.
